GIVEAWAY RULES



MOS Fair 2025

1. Organizer of the Giveaway

The organizer of the giveaway is Sinteza d.o.o. – Casino Game (hereinafter: the “Organizer”).

2. Duration of the Giveaway

The giveaway takes place during the MOS Celje Fair 2025, from September 17 to September 21, 2025, at the Casino Games exhibition booth in Hall K, stand K16.

3. Prizes

- Grand Prize: Organization of an exclusive event worth €2,000.
- Daily Prizes: Each day of the fair, a poker chip case will be awarded.

Prizes are non-transferable, and cannot be exchanged for cash or any other form of compensation.

4. Conditions of Participation

The giveaway is open to all individual persons over the age of 18 and legal entities with a registered office in Slovenia.

To participate, it is necessary to:

1. Fill out the required details on the flyer (individual or company).
2. Submit the completed flyer into the giveaway box at the Casino Games exhibition booth.

By submitting the completed form, the participant is deemed to accept these rules and terms of the giveaway.

5. Prize Draws

The daily prize draws will take place each day of the fair at 16:00, while the grand prize draw will take place on Sunday, September 21, at 16:00.

The draws will be held publicly at the Organizer’s exhibition booth, and the results will also be published on social media.

6. Announcement of Winners

Winners will be announced live at the Casino Games exhibition booth. All winners will also be published on the Organizer's official social media channels.

If the winner is not personally present at the announcement, they will be notified through the contact details provided on the form.

7. Prize Collection

Daily prizes can be collected directly at the Casino Games exhibition booth until the end of the fair. If the prize is not collected at the fair, the winner can claim it within 10 days after the conclusion of the giveaway, by prior arrangement with the Organizer. The Organizer may also send daily prizes by post to the address provided by the participant at registration.

The grand prize will be coordinated and delivered individually, with the method and timing of collection agreed directly between the Organizer and the winner.

If the winner does not respond to the Organizer's notification within 10 days after the conclusion of the giveaway, the Organizer reserves the right to award the prize to another drawn participant.

8. Personal Data Protection

The Organizer ensures the protection of personal data in accordance with applicable legislation (GDPR and ZVOP-2).

By submitting the form, the participant authorizes the use of personal data for the purpose of carrying out the giveaway.

Personal data will not be shared with third parties.

9. Liability

The Organizer does not assume responsibility for:

- incomplete or illegible forms,
- any technical issues during the implementation of the giveaway,
- circumstances beyond the Organizer's control.

10. Final Provisions

The Organizer reserves the right to amend these rules if required for technical, substantive, or organizational reasons.
